- c plan by brainstorming and revise own writing by adding more information; 8E-WP 1C
- d use content specific vocabulary when writing about a topic. 8E-WP 1D

- a write a research report to answer a question based on two or more sources of information; 8E-WP 2A
- b identify quotes from print or digital sources that provide information about a topic. 8E-WP 2B

- c use information from literary and informational text to support writing (e.g., “Recognize the difference between fictional characters and nonfictional characters.” “Delineate the specific claims in a text.”); 8E-WP 4C
- d use information from literary or informational text to support writing by using specific claims in a text. 8E-WP 4D

- a use standard English rules when writing by using question marks at the end of written questions. 8E-WE 1A

- b spell words phonetically, drawing on knowledge of letter-sound relationships and/or common spelling patterns. 8E-WE 2B
